
# **Energy performance certificate** (EPC)



#### Rules on letting this property

Properties can be let if they have an energy rating from A+ to E.

If a property has an energy rating of F or G, the landlord cannot grant a tenancy to new or existing tenants, unless an exemption has been registered.


From 1 April 2023, landlords will not be allowed to continue letting a non-domestic property on an existing lease if that property has an energy rating of F or G.

This property's current energy rating is D.




Properties are given a rating from A+ (most efficient) to G (least efficient).
